I have started summer office hours as there simply just aren't a lot of real property time sensitive issues, at least until the school tax bill are mailed on September 1. Besides a random email or text message, the public interaction at this time is minimal however that doesn't mean the work stops.

Start of Data Verification

I have started to review the inventory of property and I started with the last map section (250.00). I have started to review somewhat recent aerial imagery to confirm building footprints, decks, patios, garages, and other accessory buildings that are easier to confirm from a desktop as opposed to being out on the street. I have found numerous occasions of new decks, garages, etc that were not captured on the inventory. The next step is do a field parcel by parcel inspection to confirm the physical condition of the properties in order to see exactly what state the inventory is in.

Buildings & Grounds – Need to check the outside lights on the town hall because they are still on in morning.

Old Business

Town Hall Pavilion – Don and Joe traveled around to look at other pavilions that have been built in the area. Talked to a few construction outfits and will have to consider the "prevailing wage" standard. North Street Drainage Improvement update: Don contacted CC Soil and Water to let them know that there is a change in the thought process of where the repair needs to be done. NYSERDA \$5000 grant – The board agreed to use the funds for Town Barn lighting upgrades and if there are funds leftover, give out LED bulbs at the Fall food giveaway. Swim and Recreational Program – Lower registration than last year possibly due to conflicting Summer programs such as soccer and other summer camps. Rough estimate for the four township costs: Genoa – 16 participants, \$3937.71; Ledyard – 4 participants, \$967.16; Scipio – 7 participants, \$1727.07; Venice – 1 participant, \$276.33. REV Theatre Program – Low attendance this year.

New Business

Seneca County Cooperative Extension sent an invitation to tour water quality facilities and other town facilities in Seneca County on August 15. Paul and Don will attend. Southern Cayuga Ambulance planning on a deficit of \$36-\$50k at the end of the year. Staples On-line Office Supplies is no longer using the CitiBank account cards. Businesses will have to place orders using business credit/debit cards.
