SUPERINTENDENT OF HIGHWAY REPORT

The highway guys are grinding Long Hill with Cayuga County. Also ditching Shingle Valley, Bartnick, May and Creek roads. The crew have been working on the Maple Street ballfield. The guys used pressure water run to clean out the culvert pipes on Bartnick Road and replaced one driveway culvert that they couldn't get through. The drainage problem at Five Corners was repaired. The guys have been checking and repairing water meters that didn't read at the beginning of May. The highway guys helped Niles pave.

C.H.I.P.S Appropriation for 2024 is \$241,568.00. After rolling over from 2023 we have a total of \$314,627.58. The end of June the Genoa water tower will hopefully be repaired. Price of salt will be increasing. Paul purchased salt a current price which should last throughout the year. There is a concern of residents filling in ditches along side the road in front of their homes. The ditches are there for a reason and should not be filled in.

Paul and Scott Swan will be attending the Water Conference on the week of May 20th. Chris McKane submitted his resignation to take another job.
