# **HIGHWAY REPORT**

In August, the men have been hauling limestone for chip sealing and preparing shoulders for seal coating. The cold pavement on Mahaney Road and Center Road is completed. Some sections still need shoulder work done before completion. Six miles of seal coating has been completed, with more coming next week.

Frank has been working with NYMIR Insurance and Liberty Mutual, on bills that were incurred from the roller accident and the lightning strike that took out our electronics at the garage. Both were satisfied with the pictures and the estimates that Frank sent to them and have agreed to cut checks for coverage, minus the deductible.

Silverline Construction has finished the bridge repairs on both Blakely Road bridge and Creek Road bridge for the removal of the yellow flag and the red flag condition that was placed on them by NYSDOT. James Gorzynski, our P.E. from Fisher Associates drew up the plans for the work to be done and met with Frank and Dave Kelly at the sight to discuss the plan of repair. Being an emergency situation, the project was started ASAP. Now James is once again working with DOT to remove the flags on both bridges.

The Town has just received our new 2014 loader on the John Deere buy-back program from 5-Star Equipment. This unit came with the new final tier motor, which will meet emissions for the 2016 model and reduce the trade price even lower.

The new box was installed from Kurtz Equipment in Marathon. A new sander door was fabricated and installed, at a fraction of Harder's price. Looks good and works great.

#### **SECTION 1. TITLE.**

This Local Law shall be referred to as "Local Law #3 of 2014"

## SECTION 2. PURPOSE AND INTENT.

By the enactment of Local Law #3 of 2014, the Town of Genoa has official authority to establish a Constabulary. This constabulary's title is Court Security Officer.

# SECTION 3. DUTIES OF THIS OFFICER DURING COURT SESSIONS:

- Operate magnetometer prior to people entering the court room
- Escort Judge, jury and witness(es) to and from the courtroom during a jury trial
- Protect and guard public, Judge, and employees in the court
- Check to ensure identification is in order when necessary
- Provide general information to visitors on premise
- Prepare incident reports when necessary
- Provide assistance in emergency situations
- Physically restrain unruly individuals if needed
- Other duties as assigned by presiding Judge

## **SECTION 4. EFFECTIVE DATE:**

This Local Law shall take effective immediately upon filing with the New York Department of State

With no further business, on a motion of Board member Shields, seconded by Board member Slocum, both meetings were adjourned at 8:15 p.m. Carried unanimously.
