## **HIGHWAY REPORT**

#### Paul Wheeler

The men have hauled sand in from O'Tooles gravel pit in Moravia, mixed it with salt and stacked it in the salt shed. We also helped the Town of Locke with some paving and Cayuga County Highway replacing shoulders on Indian Field Road.

Shop work - we have replaced bearings and bed chain in the sander for truck #1, sand blasted and painted the rims and bucket on our payloader, and removed the front mounted hydraulic pump on truck #9 for repair. Trucks are being serviced for winter.

Two bridges on Creek Road have been yellow flagged. The first bridge, south of Mayo Road, is in the worst shape. It will cost \$750,000 to \$1,000,000 to rebuild at today's prices. The other bridge can probably be saved with some work.

It was decided that dusk to dawn lights will be purchased for the Town of Genoa sign.

# NEW BUSINESS

The annual meeting of the Maple Cemetery Association will meet on October 17 at 6 pm at GHA.

Early voting is being paid for by Albany.

The town received a letter from the State Comptroller. It was to notify the Town that the 2018 fiscal stress score is 3.3

The Insurance Services Office (ISO) shared a letter addressed to the Code Enforcer that will evaluate building code enforcement regulations in the town. They do this every few years. Cheryl reported on the cost/benefit analysis for the LED street lighting plan.

the conversion cost is \$2800

the estimated yearly savings is \$5400

The Cayuga County Shared Services Agreement indicates that fuel purchases among the towns in Cayuga County could save \$150,000 for 2020 and \$155,000 for 2021. The towns already share equipment and services.

Cornell Design reached out to offer their services. The Town doesn't need their services at this time.

The Board is not happy with the telephone service Spectrotel has set up for us. Phones have not been working and lines have been crossed between offices. Lorie is in contact with them.

The Board discussed the 2020 Preliminary Budget. A Public Hearing has been scheduled for November 6 at 6 pm at the Town Hall.

With no further business, on a motion of Board Member Shields, seconded by Board Member Stout, the meeting was adjourned at 9:15 p.m. Carried unanimously.
